Frequently Asked Questions

What if I want a burial?

As costs and arrangements can vary dramatically throughout the UK you should discuss these issues with us directly or with your local independent funeral director once your plan has been completed. Feel free to call us for more information and to discuss your needs. This element can be dealt with after the creation of your plan.

Can I personalise my plan?

The Open Plan is designed to be as personal to you as you wish; choose one of the standard plans and personalise that with your own preferences including readings, songs, hymns, flowers, donations to charity etc. For anything else simply contact us and we will help you with the details.

What happens if I die while on holiday or away from home?

Your funeral director will arrange collection from anywhere in the UK, although a fee may apply. If you die abroad then repatriation costs will be incurred. Please check that your normal travel insurance policy covers this.

Is my personal information safe?

Yes, of course. Any information that you provide us with is held securely and is not shared with any 3rd party. The only people that have access to and sight of your details are the team at Open Prepaid Funerals as required in their day to day duties and the nominated funeral director, for the purposes of accessing your plan and carrying out your funeral at the time of need, and possibly an accountant or actuary in the carrying out of their professional services on behalf of the Open Prepaid Funerals Trust. Your details will never be shared for commercial gain.

What if I die before I have paid in full?

The plan will continue as you have requested and your estate or relatives will pay the balance.

Is my money safe?

Absolutely, your payment is deposited into the Open Prepaid Funerals Trust Fund where it is managed by a board of trustees. The trust fund is a wholly separate entity and independent from Open Prepaid Funerals Limited.

What does local collection mean?

Local collection can vary depending on area but will normally mean within 10-20 miles across the UK. Variations might be in London where it could be a smaller radius or in more sparsely populated areas it could mean further.

What happens if I move?

Your Open Plan is completely portable; you may nominate another funeral director in the UK or if you wish, cancel the plan and receive a full refund (excluding the original admin fee of £195.00) but there are no further cancellation fees unlike other providers.

Can I transfer my plan to another person?

Yes you can, your Open plan is completely transferrable should you wish. Please contact the team directly to discuss your needs.

Can I choose my Funeral Director?

You can propose any funeral director and we will assess and confirm their acceptance of your prepaid funeral plan with you.

What do I get with my plan?

Once you've taken out your plan with Open you'll receive a pack with a brochure document folder and it will contain your Plan Certificate, Plan Summary, a copy of the terms and conditions, a 'What to do at the time of need' card and a credit card sized card for you to keep easily accessible with our contact details on it. Should you want it you can also have access to your plan online where you can see its details and request any changes or additions.

Do I have to include disbursements?

No you don't but we do recommend it. If you do choose to exclude a contribution towards disbursements, currently set at £1,100.00 (or £840 for a Direct Cremation Plan) for Open plans, they will need to be covered at the time of need. Unfortunately, because disbursement costs are not set by funeral directors the rate at which these costs increase are not in the control of the funeral director. All but our Simple Plan include disbursements and you can edit the amount included if you want to.

What Happens Next?

If you're happy with all the information you have received and wish to go ahead with your Open Prepaid Funerals Plan then simply complete the application form either yourself or with your chosen funeral director and send it to us using the freepost envelope or set up your plan online at www.openprepaidfunerals.co.uk.

The Open Prepaid Funerals Trust Fund

The assets of the Trust Fund are independently audited annually and an actuarial report is prepared by independent actuaries in line with the Financial Conduct Authority's (FCA's) guidelines. The assets are held in a segregated account on behalf of the trustees, separate from the assets of Open Prepaid Funerals Limited.

The Open Prepaid Funerals Trust Fund is invested to achieve capital growth over the medium to long term (5 years +) in a diverse portfolio of assets. The assets are held in collective funds (OEIC's) managed by some of the world's largest asset management companies chosen by the trustees after a rigorous selection process, assisted by independent financial advisers. The performance of the Trust Fund is monitored continually and measured against standard industry benchmarks to ensure above average returns with appropriate controls on risk and volatility.
